Below are instructions about opening a **USD** or **EURO** forex managed account with Rizk Investments Group by setting up a forex account with Man Financial Canada.

1. **Please download ALL the required forms which can be found here:**  
<http://www.forexforecasts.net/forms.htm>
2. When filling out the Man Financial – Trader Agreement please pay attention to the following items:
  - a) ON PAGE 5 – Check off “MINI” for the *Platform Type* (regardless of account) size & “Managed” for *Trading Type*.
  - b) ON PAGE 6 - Fill out the REFERRAL section by checking off the box called *Referral Agent* and by printing "**Rizk Investments Group**" beside *Referral Agent Name*.
  - c) ON PAGE 10 - Use "**Rizk Investments Group**" as the *Trading Agent* and check off the box called Percent Allocation Management Module (PAMM). If you are opening a new account with Man Financial print "NEW" beside the *Account Number Field* and print "0" beside *Spot Currency Trading Commission* and “0” beside *Currency Options Trading Commission*.
3. Please fill out and complete the R.I.G. Asset Management Agreement.
4. Please fill out and complete the Man Financial – Fee Payment Authorization Form.
5. Please fill out and complete the Man Financial – Margin Change Form.
6. Please fill out and complete the Man Financial – Cover Sheet.
7. APPLY BY **FAX** or **E-MAIL (\*\* PDF format only \*\*)**:
  - i. Send the following documents to **Man Financial Canada:**

    - a) A completed Man Financial – Cover Sheet.
    - b) A completed Man Financial – Trader Agreement.
    - c) A completed Man Financial – Fee Payment Authorization Form.
    - d) A completed Man Financial – Margin Change Form.
    - e) **Proof of ID** (such as a driver's license, passport or social security card).
    - f) **Proof of residential address** that is found on the application (such as a utility bill or bank statement, Note: P.O. Boxes are NOT acceptable).
  - ii. Send the following documents to **Rizk Investments Group:**

    - g) A completed R.I.G. Asset Management Agreement along with Proof of ID.
